



## Important note for full and field members:

Custodians once again, subsidize part of full and field members' SATIB Risk Insurance / EVAC 911 fees this year. The SATIB24 Risk Insurance / EVAC911 contact numbers and policy number will be emailed to you upon receipt of your payment.



#### Full and field members, please add the SATIB contact details and policy number to your cell phone contacts.

- This insurance is not a substitute for medical aid or travel insurance. Instead, it acts as a first-response tool for critical incidents.
- Full, Full Life, and Field members will receive confirmation of their In-Country SATIB/EVAC 911 In-Country cover within one week of membership fee payment reflecting in the Custodians bank account.
- In-Country cover means that you will be evacuated, if needed, to a hospital in the country where the incident happened.
- All Africa cover provides evacuation services to a hospital in another country, if needed. Please let Nonkie know if you opt to have All Africa cover, that we can provide your details to the Insurance company and adjust your membership fee.

# Allocation of 2024 & 2025 Export Quotas for elephant, black rhino and leopard:

We have forwarded the Custodians submissions to members via WhatsApp on the 22nd of December. As the Government Gazette Notice was only published in newspapers on the 6th of January, the closing date has now been extended to the 6th of February.

#### Firearm Licensing: Section 16A Status

The Custodians are accredited with the Central Firearms Registry and are authorized to award Section 16A "Professional Hunter Status" under the Firearms Control Act to active professional hunters.

This enables members holding valid professional hunter permits to license their firearms under the professional hunting category.

#### Firearm Licensing: Endorsement of Applications and Renewals

The Custodians can also endorse your motivations for new firearm license applications or renewals for:

- Section 16A: Professional hunting purposes
- Section 20: Business purposes
