#### LEGISLATION

#### Draft National Elephant Heritage Strategy – Call for Comments

The Minister of Forestry, Fisheries, and the Environment, Dr. George, has published the Draft National Elephant Heritage Strategy (Government Gazette No. 52004, Notice No. 5787) for public comment.

The document was shared with Custodians members via WhatsApp. We have been informed that the closing date for submissions is the 2nd of March. The Department will be hosting a virtual session to present and engage with stakeholders on the draft Strategy on the 21st of February from 11:00 - 13:00. If you're interested in attending, please let Adri know so she can forward you the link.

Custodians members can also email their comments to us for consideration to be included in our official submission. This strategy outlines a national vision for elephant conservation and management, guiding policies such as the Elephant Norms and Standards, National Elephant Research Strategy, and reserve-level management plans.

#### **CITES COP20 Invitation to submit proposals**

The Department of Forestry, Fisheries, and the Environment (DFFE) called for stakeholder proposals ahead of the 20th CITES CoP taking place in Uzbekistan from 24 November to 5 December 2025. Proposed amendments to CITES Appendices I and II could have lasting impacts on sustainable use and conservation. #### Leopard Consultative Forum

Custodians serves on this forum and have participated in two workshops on national level last year. The Department of Forestry, Fisheries and the Environment (DFFE), also hosted various stakeholder consultations through-out the country during 2024.

The Department recently provided us with the consolidated stakeholder consultation report and expressed their appreciation for the support that was given during the stakeholder consultations towards the development of the conservation tools for leopard, cheetah and lion. **CLICK HERE TO READ** 



#### **CITES STANDING COMMITTEE**

The CITES Standing Committee recently met in Geneve, Switzerland.

We are awaiting a report from our international colleagues (CIC, SUO, Conservation Force, etc.), to share with members in our industry, in our next newsletter.

#### CUSTODIANS LEGAL AID FUND

Our organization regularly submits comments on proposed legislation, most recently on the export quotas. Last year, we also made substantial comments to the draft NEMBA Bill. Given the complexity of the Bill and its potential impact on the hunting and wildlife sector, we enlisted the expertise of an environmental lawyer to assist in drafting our submission. Additionally, we provided members with a template for individual submissions. While Custodians always prioritizes open communication and collaboration with government departments, the EXCO has identified the need to establish a Legal Aid Fund. This fund will enable us to take or support legal action if no alternative measures exist to protect the future of our industry.

We appeal to our members to contribute to this fund so that we are prepared should legal intervention become necessary. Please complete the donation form attached to your email to make your contribution.

#### SA tourism industry bets on new travel initiative to unlock a wave of tourists from China, India

The Trusted Tour Operator Scheme (TTOS) is now live, allowing travellers from India and China to submit group visa applications via trusted agents.
