Register for Your RPL in Professional Hunting Before the June 30, 2025 Deadline

This is an important reminder for all members who still want to register for their Recognition of Prior Learning (RPL) assessment, with the aim to obtain a national qualification (CATHSSETA Certificate). The deadline for registration is 30 June 2025, just a few months away!



If you have decided but not yet started the process, we encourage you to do so as soon as possible. The RPL is a critical step in ensuring that your experience and expertise are formally recognized under the new regulatory framework. GOVERNMENT FORUMS & LEGISLATION

Custodians submission to the proposed Elephant Heritage Strategy

We have submitted our comments on the proposed Strategy to the Department. Our submission views the draft Strategy as a framework for planning and decision-making regarding landscapes with elephants. Combined National Wildlife Forum & Wildlife-Wellbeing Forum meeting:

The national wildlife forum was formed during 2005, providing an opportunity for National DFFE, Provincial Nature **Conservation Authorities and stakeholders** within the wildlife industry, like Custodians to discuss regulatory matters affecting our industry. The Wildlife Well-being Forum exists for 1-2 years is made up by, what we generally would refer to as ARA associations, e.g. NSPCA, Blood Lions, Humane Society, Four Paws, etc. Both forums remains consultative (no binding decisions taken at meetings) for: -Discussions without prejudice to either parties (party of wildlife or well-being) -without prejudice for government. Currently, the wildlife forum members may sit in as observers in a Wildlife Well-being Forum, but not vice versa.

At the inaugural annual combined meeting in early March, the chairmen from both forums presented their mandates and objectives. From the wildlife forum side, Mr Matibe made it very clear that our government supports the principle of sustainable utilisation, which remains imperative as a policy. The purpose of the meeting was for members of the two forums to identify areas of common interest on which they can have joint collaboration, which eventually did not happen and Mr Matibe proposed that the forums take it upon themselves to discuss it further within their respective forums, with the goal to identify such areas on which they will be able to work together, e.g.: the upliftment of rural communities.

AFRICA NEWS OPHAA (Operators' and Professional Hunters' Associations of Africa): Adri taking up the chairperson position on behalf of Custodians

Congratulations to Adri, who was recently confirmed as the OPHAA chairperson, on behalf of Custodians as chair-association. This follows the OPHAA CEO stepping down in early January. We look forward to the new OPHAA Exco and members, driving the OPHAA mission statement forward: Africa's recognised professional hunting, guiding and operators' organisations support the conservation and ecologically sustainable development and use of natural resources for the benefit of current and future generations through the promotion of ethical hunting.

The purpose and scope of OPHAA is for member associations to subscribe to and comply with an African Cross Border Hunting Policy, agreed to by all.



The Aims and Objectives of the Policy entails amongst others, developing fellowship and cooperation among professional hunters and organisations in Africa, to promote and safe guard the hunting profession in Africa, sustainable hunting as a conservation tool through responsible wildlife management and utilisation, the empowerment of all Africans wishing to participate in the hunting profession, engagement with governments, adherence to Associations' codes of conduct, etc. OPHAA members currently consist of: Botswana-BWPA; Ethiopia-EPHA; Mocambique-AMOS; Namibia-NAPHA; South Africa-Custodians and SAHGCA Tanzania-TAHOA; Zambia- PGOAZ ; Zimbabwe-ZPHGA

CIC General Assembly:

Through discussions with the CIC leadership in Hungary and fellow-CIC members in South Africa, Custodians has played an important role in formalising an official CIC South African Delegation and we congratulate the SA Wildlife College for being elected as the chairassociation, with Dr Thabang Teffo taking up the position as chairperson. Custodians look forward to contributing to the discussions and ensuring that South Africa's professional hunting and conservation sector remains actively involved on the world stage. Adri will attend the CIC General Assembly to be held in Doha at the end of April. The event provides a key platform to engage with global stakeholders, discuss pressing conservation matters, and strengthen collaboration for the sustainable use of wildlife resources.

Help Update the IUCN Red List for Servals!

Prof. Lourens Swanepoel, the lead assessor for the IUCN Serval (Leptailurus serval) assessment, is seeking input to update the species' Global Red List status. If you have any relevant info, your contribution would be greatly appreciated!

They're specifically looking for: Sightings & records – Camera trap data, survey results, or confirmed sightings Mortality data – Roadkill, human-wildlife conflict, or disease-related deaths Legal trade info – Permits for live trade, hunting, or skin trade Illegal use – Poaching incidents, confiscations, or reports of servals in the illegal pet trade.

Deadline for submissions: 30 June 2025

My Journey to an Unforgettable Experience - Nonkie Kunene

The road to earning my Professional Hunter certificate at Kobus Schoeman Hunting Academy was nothing short of an incredible adventure. From the moment we arrived, Oom Kobus set the tone, making it clear that the academy was built on strong Christian values—something that was reflected in everything we did.

At first, I felt completely out of place. I was the only girl in a group of guys and tried my best to blend into the background. That plan failed fast when I was moved right to the front row, sitting directly across from 0om Kobus—like a student caught misbehaving in class!

Diving Into the Theory

There was no easing into the course. Lessons kicked off immediately with the history of safaris in South Africa, the Limpopo hunting ordinance, and trophy measuring methods. By the time we wrapped up at 10:30 PM, our brains were fried—and we still got homework to do! Mornings started early, packed with intense sessions on trophy handling, firearms and ballistics, and spoor identification. Our first ballistics test was a complete disaster—the highest score was a miserable 5/30! We then moved on to practical sessions, tracking animal footprints, identifying trees and grasses, and refining our trophy judging skills. Evenings were just as demanding, with more lessons on hunting laws and, of course, more homework.

From Tracking to Shooting

As the days went by, we covered everything from hunting techniques and photography to the delicate skill of trophy caping. One of the funniest moments for me was when we had to give speeches about our favourite trees..... not exactly what I expected from a hunting academy! Bowhunting theory was fascinating. Learning about different types of bows, the mechanics, and how it is used in hunting, gave me a new appreciation for the sport. Bird and animal identification was another challenge altogether, trying to recall tiny details under pressure was no easy feat.

Then came the shooting evaluation, a mix of terror and excitement. Holding the rifle, lining up the shot, and pulling the trigger with everyone watching was nerve-wracking. But thanks to our member Michael Botha's coaching beforehand, I managed to hit a bulls-eye during speed shooting—a moment I'll never forget!

Bringing It All Together

As we neared the end of the course, our schedule was jam-packed. We tackled bird hunting, shotgun training, CITES regulations, and even an in-depth look at hunting vehicles and accommodation. When it came to trophy skinning and judging, I finally felt confident—huge thanks to Paul Stones for teaching me how to measure trophies according to SCI and Rowland Ward standards. I aced it!

Our last challenge? Accompanying clients, and I'll admit, I struggled with this one. Trying to maintain a serious, professional whisper while fighting off giggles was harder than I expected!

Then came the final exams. The general exam was brutally tough, but thanks to my background in law, the Limpopo Hunting Ordinance test felt much easier. Even Aunty Caroline Bopape from LEDET, who is usually warm and friendly, had her serious invigilator face on, as she oversaw our final assessments.

The Big Moment

Finally, the moment we had all been waiting for, certificate day. Those of us who passed received our Professional Hunter certificates, marking the end of an exhausting, challenging, and truly unforgettable journey.

A massive thank you to the Custodians EXCO for making this experience possible, and to Oom Kobus and the entire team at the academy for their patience, guidance, and for pushing us to be our best.

This wasn't just a PH-course, it was an epic adventure that I'll carry with me forever!
