We were informed at the end of March, that Turkish Airlines no longer transport any hunting trophies to the UK.

IMPORTANT UPDATE: FMD Disease Management Areas in KZN Impact Hunting Trophy Movement

Custodians would like to provide clarity following recent engagements regarding the movement and export of wildlife trophies from Disease Management Areas (DMA). Please refer to paragraph 2.2.2 of the Protocol (below).

1. We have confirmed on the 9th of April with Dr Kyle from KZN, that you will be able to move trophies out of the DMA area, WITH a Red Cross Permit.

2. When doing so, we advise that you also include a copy of the protocol you have followed to ensure that the trophies have been treated according to the Protocol. This will come in handy when being stopped by the Police or other authorities.

3. Our main concern is Bullet #4 of paragraph 2.2.2 of the Protocol (see below), stipulating that trophies from the DMA's cannot be exported.

Protocol Paragraph 2.2.2: Trophies, bones, horns, teeth and skins from game animals: Moving **OUT OF** or **WITHIN** the DMA is permitted, **provided that**:

* Skins have been salted for 28 days, or dried.

* Bones, horns and teeth have been thoroughly cleaned and dried.

* Trophies, bones, skins, horns and teeth from game animals must be covered in an impervious plastic sheet during transportation.

* No trophies, skins, horns, teeth and hides from the DMA may be exported.

* No hooves may be removed from the place where animals were slaughtered.

4. In response, Custodians has engaged with SATTA and PHASA and contacted the Director: Animal Health, in Pretoria to discuss the possibility of exemption. We acknowledge that any exemption will ultimately depend on the FMD (Foot and Mouth Disease) requirements of our export partner countries, which may vary significantly.

Due to the uncertainty surrounding the specific requirements from various countries concerning trophies from FMD DMA's, we recommend that taxidermists apply for exemptions from their State Veterinarians based on the protocols they adhere to during the taxidermy process.

🛪 Runway Compliance Alert: Impact on Safari Air Access

SATSA has issued an urgent alert regarding Regulation 139 Subpart 5, now being enforced by the South African Civil Aviation Authority (SACAA).

This regulation requires all runways to be both licensed **and** formally approved. Without both, no aircraft (including helicopters) may legally operate there.

Several safari lodges have been affected, despite having licensed runways, due to pending final approvals. Air access to these destinations is temporarily paused not due to safety concerns, but purely due to compliance status. SATSA and Federal Air are working proactively with SACAA and stakeholders to fast-track approvals and minimise disruption.

Biodiversity Economy Mega-Hubs:

Nonkie attended the North West "Biodiversity Beneficiation Mega Hub" Workshop in Rustenburg on the 3rd of April to participate and share our views. HOME AFFAIRS Extends Visa Deadline for Foreign Nationals

April 3, 2025 – Industry & Government News

Good news for foreign nationals in South Africa! The Department of Home Affairs has extended the validity of temporary visas to 30 September 2025 for those with pending waiver applications, long-term visa requests, or appeals.

This extension applies to individuals who entered South Africa lawfully and submitted their applications through VFS Global with verifiable receipts.

Please note:

- Non-visa-exempt applicants leaving and re-entering South Africa must apply for a visitor's visa.
- The extension does not apply to permanent residence applicants.

Request for Data: IUCN Red List Assessment for the Serval (Leptailurus serval)

As part of the ongoing process to update the IUCN Global Red List Assessment for the Serval, Professor Lourens Swanepoel—Lead Assessor for the IUCN Serval Assessment—has issued a formal request for data contributions from relevant stakeholders, conservation practitioners, researchers, and landowners.

To ensure an accurate and comprehensive assessment, the following categories of information are requested:

Presence Records

Verified sightings, camera trap data, or field survey results indicating Serval distribution and habitat use.

• Mortality Data

Records relating to roadkill incidents, human-wildlife conflict, or disease-related mortalities.

• Legal Trade Records

Documentation regarding the issuance of permits for live trade, hunting, or the skin trade.

• Illegal Use

Reports involving confiscations, poaching incidents, or observations of Servals within the illegal pet trade.

📅 Deadline for data submissions: 30 June 2025

All contributions will support the accuracy and integrity of the Red List update, providing critical insights into the status and conservation needs of the species across its range.
