The recent assault on safari camps in the Niassa Special Reserve, Niassa, Mozambique, has resulted in much speculation and much rumour mongering. As with most media and self-proclaimed "journalists", sensationalism sells! Many reports that suggest both progress and regress are inaccurate.

Not to make light of the very serious situation, the destruction of livelihoods, the death of individuals and the overall threat to wildlife, its habitat and the communities that reside in the reserve through depleted conservation hunting funding, much of the now and the future is still an unknown quantity.

Over the next while, more information will be forthcoming, and clarity to where our hunting season will end, should be even more apparent. Currently we have had multiple cancellations and expect more, we do however, have clients that rely on our integrity moving forward.

Scott Talbott

Custodians extends our heartfelt condolences to the family, friends, and colleagues of Scott Talbott, who passed away on the 25th of April. Scott's passing is a significant loss to the international hunting and conservation community.

We got to know Scott as the SCI Hunters & Guides & Outfitters Liaison, but he very quickly became much more than that; he became a dear friend of Custodians and our members.



Scott is a respected figure in the global wildlife and hunting community, known for his lifelong commitment to conservation and sustainable use. His legacy includes decades of public service, notably as Director of the Wyoming Game and Fish Department, where he championed science-based wildlife management and ethical hunting practices.

IMPORTANT UPDATE: CHANGES TO THE US VISA PROCESS - Effective April 24, 2025

Are you planning a trip to the US or know someone who is? Be aware that there are significant changes to the visa application process that started on April 24, 2025. These changes could impact your chances of approval and processing times.

Here's What's New, as shared with us by a travel agent:

1. DS-160 Barcode Requirement:

Your DS-160 barcode must match your appointment details. If it doesn't match, your visa appointment will be cancelled, and you will need to reschedule and pay the US\$185 fee again.

2. Mandatory Document Uploads:

You are now required to upload all supporting documents via the CEAC portal at least 72 hours before your interview. Lastminute uploads will not be accepted.

3. Stricter Screening Requirements:

Be prepared to provide:

- A travel history for the past two years
- Five years' worth of social media information (for every account you've used)

- Strong evidence of your ties to your home country

These rules apply to all visa types, including tourist and student visas (B1/B2, F, M) as well as work and immigrant visas (H, L, O, etc.).

What You Should Do:

- Submit your application personally - avoid using a third party.

- Double-check your DS-160 barcode before making your appointment.
- Do not submit multiple DS-160 forms.

- Upload your documents early to prevent delays.

CIC General Assembly

CIC members from over 80 countries attended the 71st CIC General Assembly which was held in Doha recently. Delegates included heads of state delegations, conservation experts, youth leaders, journalists and policy makers.

Custodians attended SABHSSA's Inaugural Hunting Clinic

As emphasized in our annual reports over the past few years, collaboration with stakeholders is one of Custodians' key priorities. Therefore, when we were invited to attend SABHSSA's inaugural hunting clinic at the Southern African Wildlife College (SAWC) early May, Nonkie and Shadow-EXCO member Sarah Ripley Forsyth were registered as paying delegates to attend. Other than Nonkie and Sarah, delegates included both professional and aspiring hunters and community leaders.



Nonkie and Sarah greatly appreciated the opportunity to engage in practical activities, such as tracking and spoor identification, guided by the distinguished Mr. Pieter Nel from the SAWC. They were involved in field training, firearm safety exercises, and discussions on legislation, sustainable harvesting techniques, and industry development. Overall, they were particularly encouraged by the active participation of attendees in discussions, which demonstrated a commitment to diversifying the professional hunting sector.



Custodians participating in the Biodiversity Economy Game Meat Mega Hub workshop:

Adri attended the workshop held in Pretoria on the 5th of May. The objective of the workshop, organized by the service provider SUSTENTO, was to develop a feasibility study and business plan for establishing a game meat mega hub in South Africa.

The workshop featured a SWOT and Risk analysis intended to create a formalized system/network that will facilitate connectivity and link established compliant game meat markets (both formal and informal) with consumers at local, regional, and international levels, thereby enabling them to access game meat. We anticipate the feasibility studies for the various biodiversity economy sectors to be available by August this year.
