# **INDUSTRY NEWS**

#### **Online permit applications: Limpopo**

LEDET online permit applications have reportedly not been successful for some members. Nonkie contacted LEDET, and the main issue identified was members not submitting their registrations correctly. Here are some guidelines:

1. Ensure you click the SUBMIT button after uploading all your details; otherwise, the profile will be created but not registered with LEDET.

### 2. PH permit applications:

Attach copies of the following documentation:

- a) hunting registers;
- b) certified copy of the ID, with certification stamp not older than 3 months; and
- c) expired, signed PH permit.

### 3. For Hunting Outfitter permits application (on own land):

Attach copies of the following documentation:

- a) Certified ID copy, with the certification stamp not older than 3 months;
- b) P3 exemption
- c) Camp inspection certificate;

#### Online permit applications: Limpopo (cont...)

- d) Brochure; and
- e) Pricelist.

### 4. For Hunting Outfitter permits application (if you are NOT the landowner)

Attach copies of the following documentation:

- a) Certified ID copy, with the certification stamp not older than 3 months;
- b) Landowner's P3 exemption
- c) Landowner's camp inspection certificate;
- d) Transfer of hunting rights; and
- e) Written permission from landowner to use the camp
- d) Brochure; and
- e) Pricelist.

#### Update on PHASA's Professional Body Status and Industry Developments

Many of our longstanding members will remember that PHASA was officially registered as the professional body for professional hunting a few years ago. This was recently renewed for another five years.

In early June, Custodians took part in a workshop hosted by PHASA, attended by representatives from other professional hunting associations, training institutions, and school directors. Key topics included the creation of a fully inclusive professional body and the transition of current unit standards into a modular format for formal qualifications.

### Recognition of Prior Learning (RPL) and the Path Forward

The topic of Recognition of Prior Learning (RPL) was discussed in detail during the recent workshop. PHASA remains confident that a national qualification will, in time, become a formal requirement to operate as a professional hunter. However, we must emphasize that no legal confirmation has yet been received from the relevant provincial nature conservation authorities or the national Departments of Environmental Affairs or Higher Education.

That said, the absence of formal confirmation does not preclude the possibility that such a requirement may be introduced in the future. If introduced, there is huge uncertainty on how it will apply to professional hunters who currently hold valid PH permits originally issued based on a PH school certificate and thereafter renewed through demonstrated activities as a professional hunter. Please refer to the information previously shared in <u>Newsletter No.</u> 5/2025.

The deadline for RPL applications, is 30 June 2026. If you intend to apply for RPL, we strongly encourage you to contact Nonkie to do so as early as possible to avoid a last-minute bottleneck closer to the closing date.

We will continue to keep you informed as new developments arise concerning the professional body, RPL processes, and the national qualification framework.

#### **Controversy Over Rhino Relocation in Rwanda**

A recent Daily Maverick article has sparked debate over African Parks' decision to translocate more South African rhinos to Rwanda. # **KNOW YOUR CUSTODIANS - NO 3**

#### 7. POWERS

The Association, acting through its Executive Committee, or at general meeting, will have all the powers necessary for it to carry out its stated objectives effectively. Such powers shall include, but not be limited to:

- 7.1. the employment of staff and hiring and engaging contractors and professional and other services;
- 7.2. the appointment of the Disciplinary and Dispute Resolution Panel, the convenor of the Disciplinary and Dispute Resolution Panel and prosecutors in disciplinary hearings;
- 7.3. the institution or defending of any legal or arbitration proceedings and the settling of any claims made by or against the Association;
- 7.4. the opening and operating of accounts with registered banks;
- 7.5. the making and varying of investments and re-investment of the proceeds of such investments on condition that any investments made by the Association shall be with registered financial institutions;
- 7.6. the acceptance of donations made to the Association and retaining them in the form in which they are received, or selling them and utilizing the proceeds in terms of the powers granted in this clause 7;
- 7.7. the purchase and acquisition of property and assets, whether movable, immovable or intangible;
- 7.8. the maintenance, management, development, exchange, leasing, selling, or in any way dealing with the property and assets of the Association whether movable, immovable or intangible;
- 7.9. the donation and transferring of property and assets of the Association to organisations with the same or similar objectives;
- 7.10. the power to borrow and to use the property or assets of the Association as security;
- 7.11. the guaranteeing of the performance of contracts or obligations of any person on condition that any such person is primarily engaged in activities which further the objectives of the Association;
- 7.12. the execution any act or deed in any deeds registry, mining title or other public office;
- 7.13. work in collaboration with other organisations and to amalgamate with any organisation with the same or similar Aims and Objectives;
- 7.14. the exercising of all the management and executive powers that are normally vested in the board of directors of a Company;
- 7.15. To make rules as envisaged in clause 11 of the Constitution
